WHAT DOES INFINITI FINANCIAL SERVICES DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and transaction history
- Account balances and payment history
- Purchase history and account transactions

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Infiniti Financial Services chooses to share; and whether you can limit this sharing.

| Definitions | |
| Affiliates | <p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ■ Our affiliates may include companies with a Nissan or Infiniti name. Infiniti and Nissan dealers are not affiliates. |
| Nonaffiliates | <p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ■ Infiniti Financial Services does not share with non-affiliates so they can market to you. |
| Joint marketing | <p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our joint marketing partners include</p> <ul style="list-style-type: none"> ■ Infiniti dealers ■ Other financial institutions |

| <p>In California, IFS does not share with Infiniti dealers or other financial institutions for joint marketing, but does share with Infiniti dealers so we can offer you incentives, discounts or bonus programs.</p> <p>Infiniti Financial Services is a division of Nissan Motor Acceptance Corporation.</p> | |
